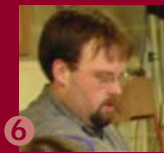

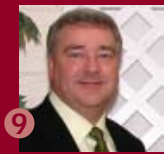

# What does a Valley City State University education add up to?

I found myself thinking about this at Commencement 2005, looking out at one of the largest graduating classes in recent times and seated next to Jerry Topp, our speaker and a 1974 alumnus.

Through most of our history, a standard answer to that question would have been unanimous: "VCSU adds up to great teachers for K-12 schools." That simple phrase speaks volumes about the university's impact on young people, on the teaching profession, and on society. It is a well-earned response of which we are justly proud, and the state and nation can be duly grateful. Teacher education is our heritage and our foundation.

So it came as something of a shock when state officials indicated that offering a Master of Education degree here would require a mission change. Their definition of "mission" hinged on degree level more than expertise and focus. After many years of discussion and three years of intensive planning, we are grateful that state officials endorsed our point of view in January. We hope to have final approval from our accrediting agency late in the summer and begin offering graduate classes in fall or January. Some folks may think we have forgotten teacher education because we talk so much about technology. There are at least three responses to this. First, the importance of lifelong learning and graduate degrees for teachers makes the master's degree a huge step forward in serving our teacher education mission. Second, the university's commitment to teacher education is evident in the huge amount of academic and administrative effort and expense required to get this far in the quest for approval, let alone what it will take to launch and sustain it. Third, listen to the principals who hire our teacher education graduates and check our placement rate – that the university's commitment and the faculty's leadership with technology have given our graduates an extraordinary edge. Teacher education remains absolutely central to Valley City State University both in spirit and in action.

In today's world, universities need to diversify their programs. It is unwise to put all one's eggs in the same basket. That is why the university added business and computing programs 30 years ago and why we are adding psychology, health sciences, professional communications, and other degrees. It is also important to stand out from the crowd, as we do with the laptops and smart classrooms that faculty use to deliver a "technology-enriched" learning experience here.

Now we are adding a Customer Relationship Management (CRM) track in the business/computing program in collaboration with the city/county

economic development group and Eagle Creek Software Services, which is creating a software development center in Valley City. We will be one of the very, very few universities in the nation where people can learn this very complex software and how to help businesses use the software. In so doing, we will be saving Eagle Creek and other businesses a great deal of money they would otherwise spend on employee software training.

Now, does that sound like teacher education to you? No. Of course not. Are we abandoning our heritage? No. Of course not. We are building both teacher education and business programs. One is not at the expense of the other, and both help ensure a strong foundation for the university's future.

And would you believe that all of these developments have a common theme? The theme is preparing people for life through visionary leadership and exemplary practices in teaching, learning, and service – which just happens to be the university's mission statement. And our vision, also evident, is to attract and retain talented individuals who advance quality learning opportunities and economic growth through technology and innovation.

The education you get at Valley City State University is for real life. Our teaching graduates are renowned for their ability to function effectively on the job from Day One. They have not only theory, but also very practical knowledge and skills. The same is true for business, computing, CRM, professional communications, and the rest. VCSU graduates have an education that works. And yet it is flexible, too. Commencement speaker Jerry Topp credits his VCSU degree in teacher education as an important foundation for his journey to CEO of one of the nation's largest accounting and business services firms.

We are no longer "your father's Oldsmobile" because our commitment is to "first class transportation," and the only way to stay first class is to change. And we continue to produce outstanding teachers and other professionals. ♦

## Progress on Masters Authority Continues

In the last issue of *The Bulletin*, we announced that the Board of Directors of the State Board of Higher Education approved VCSU's request for a change of status to enable us to offer a Master of Education (M.Ed) degree. This was an important step that put our long-sought plans for offering a master's degree within reach.

Since then, we have taken additional steps in this process by

submitting our proposal to the Higher Learning Commission (HLC), our regional accrediting organization, describing the specifics of the program VCSU proposes to offer. The HLC had a Focus Visit to campus June 6 - 8 to review our proposal and our preparations. During their exit interview, we received positive feedback that continues to make us hopeful that we will offer the

first of our graduate level classes in the fall of 2005. We anticipate that we will receive their final report in August.

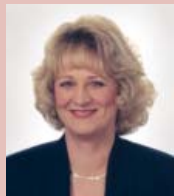

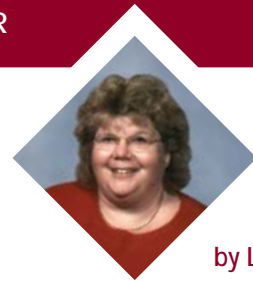
While flipping through an assortment of magazines, I read an article in

# VCSU Alums Work on Next Generation Energy Technology

## Robert Gilbertson and Brooks Hornstein work at Los Alamos National Lab on hydrogen fuel cell projects

Next time you fill up at your local gas station, watch the total spin ever higher and think of this: What if the energy we all depend on came from the most abundant resource in the world? And wouldn't it be nice if it produced virtually no pollution?

These are questions that Dr. Robert Gilbertson ('93) and Dr. Brooks Hornstein think about every day. In fact, the two have a lot in common. Both are natives of North Dakota who attended VCSU after being recruited for varsity sports by Coach Jim Dew. Both quickly developed an interest in chemistry working with Dr. Joe Stickler. Both went on to pursue graduate, doctorate and post-doctorate studies in chemistry, and both are now working at Los Alamos National Laboratory, one of the most prestigious national laboratories in the world, on separate elements of hydrogen fuel cell technology — a science that has the potential to reshape our economy and solve some of the most fundamental problems we face today.

Originally from Maddock, ND, Gilbertson appeared on campus without a specific major in mind. During Freshmen Orientation, he met Joe Stickler who eventually kindled Gilbertson's interest in chemistry. "Joe Stickler was the most exciting and interesting teacher I've ever had." He played football under Coach Jim Dew for four years as a Viking Wide Receiver, making 54 catches for 517 yards. Though the Vikings struggled during those years and despite the physical toll football took on his knee, Gilbertson loved the game and was even recognized by the NAIA as a Scholar Athlete. Said Gilbertson, "One of the things that I loved about VCSU was the small college atmosphere that lets you get to know everyone and provides lots of opportunities to get involved. I didn't realize it until I started graduate studies at much larger schools, but you don't find those things at many campuses."

Gilbertson graduated Magna Cum Laude, and went on to receive his master's degree and Ph.D in chemistry from the University of Oregon. It was here that he became involved in some of the "green" chemistry projects that give him the most pride, including working in the Materials Science Institute with Professor James Hutchison as a postdoctoral fellow. "This work was important because fifty years of plutonium-239 production at the Hanford site in Washington produced over 55 million gallons of high-level

radioactive waste that is waiting for treatment. The project I was involved in improved the efficiency of removing radioactive heavy metals, known as f-Block metals, from the waste by seven orders of magnitude (10 million times). It could provide an economical way to make the waste significantly safer for the environment."

At Los Alamos, Gilbertson is working on Polymer Electrolyte Fuel Cells – currently the best variation for transportation applications, and is already used in some electric vehicles. Although he enjoys working in science, one of the aspects he enjoys most about his work is that it has the potential to affect a lot of people. "It's a lot of fun to work on something that you know will have a significant effect on the world... if you can make it work." Gilbertson currently resides in Los Alamos, New Mexico, and enjoys visiting Santa Fe for its 400 year history (it was incorporated in 1610). Still an athlete, his hobbies include softball, mountain biking and road biking.

Another key problem with fuel cell technology is finding a source of hydrogen to use as fuel. Although hydrogen is the most abundant element on Earth, the vast majority of it is in water molecules. Harvesting hydrogen from water

requires splitting the water molecule – a process that isn't very easy.

That's the problem that Hornstein is working on at Los Alamos. Specifically, he is working on a process called photoelectrolysis. Said Hornstein, "We're working on Photoelectrolysis to use sunlight energy for breaking water molecules apart into hydrogen and oxygen. Then, fuel cells 'burn' the hydrogen by combining it with oxygen to release energy. Water is both the raw material and the waste product, making the technology

nearly 100% clean and 100% renewable."

Originally from Williston, Hornstein attended VCSU for three years, and made several appearances on the Dean's List and the President's Honor Roll. He played baseball for Coach Jim Dew as a first baseman and a left-handed pitcher, lettering in both 1990 and 1991. He decided to transfer for his senior year when he got his first taste of research during a summer program at the University of Utah. He remembers his years at VCSU as a great experience, and would like to do a better job staying in touch with old friends. "I liked the smaller class sizes, and I highly recommend small colleges for the individual attention students get. VCSU also had the nicest campus, and I liked the opportunity to play baseball. But the big advantage VCSU had to do with the people. After meeting people like Joe Stickler, it wasn't a hard decision. Even my Mom liked him!"

Hornstein is at Los Alamos as part of his postdoctoral fellowship after receiving a BS in chemistry and a master's degree and Ph.D in inorganic chemistry from New Mexico State University in Las Cruces.

He also did some work at Colorado State University between 1999 and 2003 developing mathematical models for the formation and aggregation of nanoparticles. Still an athlete, Hornstein still runs 5K and 10K events, and participated in the Steamboat Springs Marathon in June finishing with a time of 3:48 – good for 76th place out of 500 competitors. Other plans for the future include a likely move to San Jose, CA this fall when his wife, Dr. Amy Leisenring, starts a faculty job at San Jose State University. ♦

Gilbertson and Hornstein both attended VCSU in the early '90s, became friends through sharing a common major and taking many classes together, then went their separate ways and fell out of contact. Ten years later, they ended up sharing the same office at a national lab with 13,000 employees nearly 1,500 miles from Valley City. It may be a remarkable coincidence, or perhaps it says something about the type of student, and the type of teacher, that VCSU attracts.

Of course, not everyone who attends VCSU goes on to earn a Ph.D. or work at national labs on projects that have the potential to change the world. In fact, VCSU's heritage and main activity even today is serving as a teacher's college. If that seems like a big difference, consider this: neither Gilbertson nor Hornstein came to VCSU with any specific idea of what direction they wanted to take their studies. It was a teacher who inspired them and ultimately led them to where they are today.

# VCSU Receives Scholarship Fund from Charlotte Van Houten Estate

## Bequest extends her lifetime of giving and caring for the Valley City Community



The estate of Charlotte Van Houten ('29) bequest to the Valley City State University (VCSU) Foundation over \$750,000 to fund a perpetual Charlotte Van Houten Scholarship for VCSU students. The bequest was the largest VCSU has received from a resident of Valley City in its history

Charlotte received her standard degree with a major in Music Education from VCSU (then called the Valley City State Teacher's College) in 1929. She also received a Bachelor of Science degree from Western Reserve University in Cleveland, and her master's degree from Columbia University. She taught at the Hathaway Brown School, an independent school for girls in Shaker Heights, OH for 40 years, the last 18 of them as the Head of the Primary Department. She was a board member of the Childhood Education Association; a delegate for several years for Greater Cleveland to the National Conference of the Association; a member of the National Association of Independent Schools, a Jennings Scholar in 1963 for the Jennings Foundation; a board member of the Natural Science Club; and a member of the American Business Women's Association. She retired in 1975 and returned to Valley City to be with her sister, Delphine Van Houten.

Though much of her life was spent in Ohio, Charlotte always retained her connection to Valley City and VCSU. Her father was Dr. Jacob Van Houten,

a well-known and respected doctor and county health officer who practiced in Valley City from 1903 to 1960. As a child, she grew up on land that is now occupied by the VCSU Student Center, and would reminisce about the pony she kept in the back yard. In addition to giving to a variety of charities, Charlotte made annual donations to the VCSU Foundation every year since 1986, and has given to several other VCSU groups including Theatre, Music, V-500, and the Library. She was a member of Congregational United Church of Christ in Valley City, a member of Chapter A of the P.E.O. Sisterhood in North Dakota, Valley City Retired Teachers' Association; and Valley City Arts and Gallery Association. Mary Heath, the personal representative of Charlotte, said, "Charlotte believed that the arts and culture are very important for the survival of the community. She liked to think of Valley City as a small town with a lot of exciting things happening."

VCSU President Dr. Ellen Chaffee said that the bequest will be used to fund a perpetual scholarship for students at VCSU. Dr. Chaffee said, "Charlotte Van Houten was an extraordinary woman who dedicated her life to education. Throughout her career, she touched many, many young lives. Her generosity and foresight ensure that she will continue to touch young lives indefinitely into the future." ♦

# Online Technologies Help Fulfill Critical Shortage

Normally, it is the teachers who proudly watch the students graduate. But in some cases, it works the other way around.

Brian Nettleton teaches Technology Education at DeTour Area Schools located in the upper peninsula of Michigan. He received a Bachelor's degree this spring in Technology Education, a field facing a critical shortage of teachers both in Michigan and nationwide. Brian earned his degree by studying online from Valley City State University (VCSU), one of the few universities in the nation that offers degrees based on the Standards for Technological Literacy. In addition to filling a needed role in DeTour, Brian's new credentials will allow him to continue teaching Technology Education classes to other area schools (also online), helping them overcome the shortage of teachers in this area.

Technology Education is the successor to a subject that most parents knew as Industrial Arts. Having been taught at just about every school district in Michigan, Industrial Arts went through some fundamental changes to become Technology Education, including a new curriculum and new educational standards. Whereas Industrial Arts focused on topics like woodworking, Technology Education emphasizes literacy in Information Age technologies and design and problem-solving abilities.

Unfortunately, one result of all these changes is that the field is facing a critical shortage of teachers who meet the new standards. Like many states, Michigan deals with this shortage by hiring teachers who do not meet all of the academic requirements as long as they have the necessary knowledge and agree to take steps towards meeting the academic requirements within a specified

timeframe. In these situations, the state issues a Provisional (or "emergency") certification so the subject can continue to be taught while the teacher obtains the necessary degree.

In Brian's case, he was working in the commercial sector at Nettleton Wood Products when the individual teaching Industrial Arts at DeTour retired. Brian, with his background both in woodworking and technologies like Computer Aided Design (CAD), made an attractive candidate. He had the necessary knowledge for the job, but he had not completed the degree he had started at Northern Michigan University some years ago. After going through the screening and interview process, he was offered the job under the provision that he work towards a Bachelor's degree in Technology Education.

School officials and Brian both knew that a full-time job teaching while pursuing a degree is enough of a challenge, but in this case, distance would pose an additional problem – the closest college that offered a degree in Technology Education was the University of Northern Michigan in Marquette, over 200 miles away. Brian said, "There was just no way that I could quit my job for a year to take classes," so he began to look for programs that are delivered online.

He found a program at VCSU, and resumed work on his degree in the spring of 2002. VCSU's Technology Education program is the nation's first and only online program based on the Standards for Technological Literacy defined by the International Technology Education Association (ITEA). All of the courses required for VCSU's Technology Education program are available online through the World Wide Web. To make the curriculum

as convenient as possible, lab activities can be done at home or remote laboratories as well as during lab sessions on campus. The schedule of courses reflects the needs of busy, modern students - including summer courses.

In May of 2005, Brian completed his degree program with the presentation of his Senior Portfolio to faculty, an important requirement for graduation. VCSU requires their students (both traditional and online) to develop and deliver their Portfolio to demonstrate their mastery of basic abilities including Communication, Global Awareness, Problem Solving, Wellness, Collaboration, Aesthetic Engagement, Technology and Effective Citizenship. In Valley City, a group of faculty and students listened intently as Brian walked through the abilities, describing ways that his work, studies or experiences have improved his skills in these areas. With the exception of occasionally garbled sound caused by lost packets of data, the presentation was as effective as if Brian were in the

same room as his audience despite the fact that he was actually over 800 miles away.

In fact, Brian thinks very highly of online classes. "I've sat in classrooms with 30 other students over entire semesters and not really had a chance to get to know any of them very well. Online classes require students to interact with each other and the professor, for example in discussion groups, so you are forced to get to know them. I think online students actually get to know each other better than students in traditional classes."

In addition to completing his own degree online, Brian has been using online technology to teach classes in Technology Education to students in several districts around DeTour. The nationwide shortage of teachers in Technology Education forced these districts to drop their offerings, but with online technology, Brian has been able to teach students in these districts as if they were in the same room. Brian said, "The real benefit goes to students – they get options that would have never been possible before." ♦

## The President's Distinguished Service Award Re-Established

At the Valley City Barnes County Development Corporation's Annual dinner, VCSU President Dr. Ellen Chaffee presented the President's Distinguished Service Award for the first time in recent years. Chaffee stated, "More and more, our partners and friends have been crucial to realizing each exciting step toward achieving the vision. So I am re-establishing the Valley City State University President's Distinguished Service Award to recognize exceptional contributions toward our vision from our partners and friends." The recipients of the award were:

### Roger Reiersen

Reiersen is the president of Flint Communications in Fargo, president and managing partner of AdFarm, and former chair of the Greater North Dakota Association. He is also the chair of the New Economy Initiative, and was an important factor in reinvigorating hope, energy, and action for the entire state.

As a leading member of the North Dakota Roundtable on Higher Education, he helped forge an alliance between the state and higher education. He then facilitated the Valley Development Group Roundtable, a local group which used the state's report to determine the best path for making VCSU a catalyst for expanding the region's economy. He helped plan and organize a six month process for three dozen area leaders, developed agendas and presentations, put task groups to work, wrote the report, designed it, and printed it. He donated everything he did, including printing and other significant expenses. "This is a man who acts on his convictions to a degree seldom seen," said Chaffee. "He has provided distinguished service at all levels, and we are proud to recognize him for creating an environment in which higher education can be the engine for growth in North Dakota"

### Jerry Topp ('74)

Topp is managing partner and chief executive officer of Eide Bailly LLC, one of the largest accounting and business advisor firms in the county. He has been on the Foundation board for two years and he chaired the Valley Development Group Roundtable in partnership with Reiersen.

"Jerry is a believer among unbelievers," said Chaffee. "A pioneer who understands, appreciates, and gets involved with his alma mater when it would be very easy to forget or ignore us from his urban, corporate setting. In his own quiet way, he has stepped forward, invited all of us to set our sights high, and stepped into harness with us to reach those higher goals."

### The Valley Development Group

The third award recognized the Valley Development Group (VDG), a partnership of taxpayers, the city and county commissions, regional and state agencies, and others to grow the economy and the number of good jobs in the region.

In recent years, the VDG and Valley City have invested hundreds of thousands of dollars in VCSU, and have partnered with VCSU on such projects as building the Regional Technology Center and converting the Kathryn Center into Corporate Adventures, an increasingly successful new business. Their support played a crucial role in the decision by the State Board of Higher Education to allow VCSU to pursue a Master of Education degree. This year, their partnership with VCSU and Eagle Creek is bringing new jobs to Valley City and enabling VCSU to launch new and innovative programs which could lead to more new companies and more new students. "The shared vision, selflessness, persistence, creativity, and investment savvy of the Valley Development Group is unparalleled in my experience," said Chaffee. Jennifer Feist, Director of the VDG, accepted the award on behalf of the entire Valley Development Group.

The President's Distinguished Service Award has only been awarded eight other times. The recipients have been Donald L. Heimes, Dale Olson, C. "Van" Vandestreek, Ernest J. Miedema, Theron L. Strinden, Orville Barber, Herman Stern, and Carol Watson Peterson. ♦

## Two VCSU Icons Retire

Two fixtures of life at VCSU for more than 40 years retired this spring: Joan Noeske ('62) and Dr. Larry "Buck" Grooters ('57).

Joan worked in the Registrar's office while attending VCSU, and graduated in 1962 with a Bachelor of Science degree in Business Education and a composite minor in English and Speech.

She spent a total of 42 years working for VCSU, initially as a secretary in the Registrar's office and then in various roles in the business office including clerk, account tech, payroll tech, and payroll/benefit specialist. "One of the things I liked most about my job was that I got to know just about every employee," said Joan. "I've found if you treat people nice, they treat you nice. You reap lots of rewards that way."

After graduating from VCSU in 1957, Dr. Grooters joined the faculty in 1963 to teach in the Health and Physical Education Division and serve as the Head Coach of the Track and Cross Country teams, and as the Assistant Coach of the Basketball team. In 1971, he completed his Ed.D. at the University of North Dakota. In 1980, Dr. Grooters moved from the Division of Health and Physical Education into the Teacher Education program and became Chair of the division and head of Teacher Education. Under his leadership, VCSU received NCATE accreditation four times and was honored with the Distinguished Achievement Award from the International Society for Technology in Education (ISTE). He was inducted into the North Dakota Official's Hall of Fame in 1990 and the VCSU Viking Hall of Fame in 1995. He has been very active in his professional life with membership in many professional associations, and has been an active volunteer in his church. VCSU recognized his many accomplishments by presenting him with the Distinguished Alumni award for 2002.

Ellen Chaffee, President of VCSU, said that Joan and Larry embody some of the strengths that make VCSU so special. "Learning, supporting learning, delighting the people we serve, being kind, and helping each other are a few of the guidelines that all VCSU faculty and staff are asked to keep in mind as we serve students and each other. During their many years here, Joan and Larry exemplified these characteristics, and their efforts made VCSU a better place. They will be deeply missed, and we wish them the best during their retirement."

Retirement for both Joan and Larry became effective in June. ♦

This year, four outstanding individuals and one team will be inducted into the Viking Hall of Fame. Gymnast Kelly Keidel, three-sport standout Doug Black, and baseball player Steve Olson round out the former athletes that will be inducted. Elinor Olson will also be inducted in the "Special" category for her outstanding service to the university and its Athletic Department. In the "Team" category, the 1987 Baseball team will inducted for its accomplishments on the diamond. The ceremony will be held October 14th in Valley City in conjunction with Homecoming weekend.



### Kelly (Hagerty) Keidel ('88)

A four-year letter winner in Gymnastics, Kelly competed for Head Coach Terry Corwin from 1985-1988. During those years, the Vikings competed in four NAIA Gymnastics Championships. An integral part of the team, Kelly was chosen most valuable team member three of the four years. Although Kelly was a strong all around gymnast, her best events were balance beam and the uneven bars. Her signature move on balance beam was a press to handstand and a plange down. On uneven bars, she was the first VCSU gymnast to perform a cast to handstand on the high bar. She remains the record holder for the uneven bars with a score of 8.8 and is on the team that holds the team score record of 133.7. In the 1997 NAIA National meet, Kelly made finals on balance beam and finished 8th in that event and 18th all-around. In 1998, Kelly was named VCSU's Outstanding Viking Athlete.

### Doug Black ('82)

A transfer to VCSU, Doug made the most of his time as a Viking. A two-year letter winner in football, Doug also found the time to letter three times in both baseball and track and field. As a wide-receiver on the football team, he was named All-Conference in 1980 and All-Conference Honorable Mention in 1981 while helping the Vikings to an overall 15-5 record with only 2 losses in conference play. On the diamond, Doug was named All-Conference Honorable Mention for three years while winning two NDCAC Baseball Championships. In track and field, Doug competed in the 100, 200, 4 x 100 relay and long jump.



### Steve Olson ('88)

A four-year letter winner as a Viking, Steve earned All-Conference honors in 1985, 1986, and 1987, All-District in 1986 and 1987 and All-Area, Academic All-American, Honorable Mention All-American, NDCAC Most Valuable Graduate in '87. He helped his team to two NDCAC Conference Championships, a District Championship, and a berth in the Area III Championships. In his four-year career, the Vikings had an overall 42-18 NDCAC record. During his All-American season, Olson played first base and pitched. Statistically he led the Vikings in batting average (.379), hits (47), and RBI's (35).

### Elinor Olson

Chosen for her dedication and loyalty to Viking Athletics for her 25 years of service in the department, Elinor exemplified the passion, desire and commitment Viking Athletics represents. During her tenure at VCSU from 1971 until she passed away in 1997, she worked for legendary Athletic Directors Bill Osmon, Darrell Anderson, and Don Bauer.

1 All American + 4 All-District Players + 7 All-Conference Players equals NDCAC Champions, District Champions, Region III Qualifiers and induction into the Valley City State University Viking Hall of Fame. 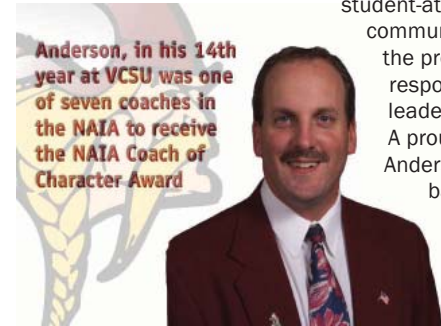




## Anderson Receives Coach of Character Award

## Adopt-a-Room at the President's House Help Us Restore the Historic President's House

The President's House Preservation Society recently announced their next major restoration project: interior wall repairs, restoration and decorating in every room on the main floor. To raise funds for this project, the society has announced a new fund-raising program: "Adopt-a-Room" in which donors may sponsor a room of their choice.



Becky Heise, Co-chair of the society, said, "The money raised will be used for purchasing supplies and materials such as plaster, paint, and wallpaper. All of the labor will be provided by the volunteers who have been doing such a great job putting in time on other maintenance and restoration projects. We have found four layers of wallpaper, so we expect a lot of work will be involved."

Heise said that this is the latest in a series of restoration projects that have been paid for by a number of creative sources. "Painting the exterior, refinishing the floors and re-shingling the roof were funded by a 50/50 match between rental income and grants from the State Historical Society of North Dakota, which administers funds provided by the National Park Service. We even sell the *Dames Club Cookbook* which features old-time recipes that have been brought up to date with modern cooking methods."

Sponsors may "Adopt-a-Room" by making a \$500.00 tax deductible gift, and will be recognized by a 4" x 6" oak plaque with an engraved bronze plate displayed in the room. All six rooms on the main floor will have their walls restored including the living room, dining room, smoking room, the entry, the reception hall, the parlor and the music room.

Dr. Richard R. McCready ('47), distinguished VCSU alumnus and founder of the McCready Scholars Endowment, died at age 80 on June 22, 2005 at his home in Sun City, AZ. He is survived by his wife of over fifty years, Ardis McCready ('49).

Dr. McCready was born in Valley City and served in the Air Force during World War II before receiving his Bachelor of Science degree from VCSU. He went on to receive masters and doctorate degrees in Education. He wrote eight successful college textbooks and was a member of Pi Omega Pi, Kappa Delta Pi, and Beta Sigma Phi, all national honorary fraternities. He was a member of the Hall of Fame of the College of Business Administration at Arizona State University from which he was Professor Emeritus.

The McCready's provided scholarships continuously at each of two universities since 1970. In 2004, they established the McCready Scholars Endowment, the single largest gift in VCSU's history, which provides scholarships for outstanding students that include tuition, fees, and books for up to four years. He also was recognized with the Valley City State University Distinguished Alumni award in 1982.

Dr. Ellen Chaffee, President of VCSU, said, "Although it was the largest gift in VCSU's history, the McCready Scholar Endowment was just one sign of the generosity and foresight of Dr. McCready. His actions ensure that he will be remembered in perpetuity for advancing opportunities for outstanding students at Valley City State University."
